**ORDER:**

In the Government Order first read above, the Government have issued orders for granting exemption under section 17 (1) (a) of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 (Central Act XIX of 1952) to M/s.Sundaram Industries Private Limited, Madurai, TN/ 197-A, subject to certain conditions specified therein.
