#### Subject: Filling up the posts of Auditor in level 6 in pay matrix (Pre-revised pay band of Rs 9300-34800 with grade Pay 4200) on Deputation basis

Sir/Madam,

It has been decided that the vacant posts of Auditor as per details in the Annexure I may be filled up from the grade of SSA/SSSAs fulfilling the eligibility criteria on deputation basis initially for a period of 3 years.

2. The EPFO officials fulfilling the following criteria are eligible to be appointed as Auditor by transfer on deputation basis :

- (i) holding analogous posts on regular basis, or
- (ii) with 5 years regular service in the pay scale of Rs 4500-7000 or equivalent and

(iii) Possessing the experience in Account/Audit of public funds.

Note: Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Government shall ordinary not exceed 4 years.

The interested candidates may be advised that the job will require intensive tour in the 3. respective audit party. It is requested that application of interested candidates in SSA/SSSA cadre in the performa enclosed at Annexure II alongwith duly attested copies of APAR for preceding 5 years, Vigilance Clearance, Integrity certificate and list of penalty, if any, imposed during last 10 years may be forwarded to Head office within 15 days of issue of this circular.
