Non requirement of submission of Non Remarriage Certificates by

widow pensioners reg.

Sir.

It has come to the notice of this office that instructions contained in circular No.Pen./Misc/2006/44884 dated 21.09.2006 are not being strictly complied with and the widow pensioners under EPS 1995 are still being asked to furnish the remarriage certificate every year. To reiterate the instructions issued vide above mentioned circular,( and in supercession of the instructions issued vide circular no. Pens.I/7 (2) 2000/CEPS/LC/Vol-II/53444 dated 17.10.2007) it is once again clarified that the widow recipient of family pension is not required to furnish a non remarriage certificate every year but shall give an undertaking at the time of commencement of pension that in the event of her re-marriage, she would report the fact to the pension disbursing office promptly. However, widower pensioner will continue to submit Non Re-marriage Certificate as usual in the month of November every year.

The Regional Provident Fund Commissioner, of the region shall specifically ensure compliance of these instructions to avoid any grievance in the area, by suitably co-ordinating with the pension disbursing agencies.

Dispensing with submission of non-remarriage certificate every

year by widow pensioners.

Sir.

As per the provisions of Manual of Accounting Procedure Part-IV (Para 23.2) widow/widower recipient of family pension is to submit the certificate of Nonremarriage in the prescribed Performa at yearly intervals i.e. in November

However under the " Scheme of payment of pension to Central Government Civil Pensioners by authorized Banks", the widow recipient of family pension, is not required to furnish a certificate of non-remarriage every year, but shall give an undertaking at the time of commencement of pension to the effect that in the event of her remarriage, she would report the fact to the pension disbursing office promptly. It is decided to adopt a similar procedure in respect of EPS,1995 widow pensioners also.

Accordingly, the widow pensioner under EPS, 1995 shall not be required to submit Non-remarriage certificate every year, instead an undertaking to the effect that, in the event of her remarriage she would report this fact to the Pension disbursement agency/EPFO immediately, shall be taken at the time of commencement of pension. The modified Proforma of Non-re-marriage certificate is annexed to this circular. However, widower pensioner will continue to submit nonremarriage certificate as usual in the month of November every year. All existing widow Pensioners may also be asked to provide the certificate in modified Performa this year, so that they will not be required to furnish Non-remarriage certificate from next year.
