2. The benefits of up-gradation of Grade Pay is subject to the following conditions:

1. This is not a promotion but a financial upgradation only under the MACP Scheme, 2009.
2. The officials will continue to hold the post of Personal Assistant.
3. The officials will not claim seniority in the next grade by virtue of this upgradation.
4. Their name will continue to be in the seniority list of grade of Personal Assistant and they will be considered for promotion to the post of Private Secretary as and when their turn as per the seniority list comes.

5. The fixation of pay of above officials will be regulated as per the para 4 of the Annexure-I of the MACP Scheme dated 19.05.2009. The financial upgradation is, however, subject to the other terms & conditions prescribed in the MACP Scheme vide Department of Personnel & Training OM No. 35034/3/2008/Estt.(D) dated 19.05.2009.
