**Subject: Mandatory Aadhaar Seeding with UAN of EPF members for filing of ECR – Extension upto 30.06.2024 – reg.**

Madam/Sir,

In partial modification of the circular dated 18.04.2023 under reference, the Competent Authority has granted an extension for mandatory seeding of Aadhaar for filing of ECR upto 30.06.2024 in respect of the certain class of Establishments i.e. Beedi making, Building and Construction and Plantation Industries (Tea, Coffee, Cardamom, Pepper, Jute, Rubber, Cinchona, Cashewnuts etc.) and for North Eastern Region comprising of States of Assam, Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland & Tripura.

2. This relaxation is being given as a last time measure and no further request would be entertained in this regard.
3. Accordingly, all the Zonal/Regional Offices are requested to make necessary efforts for seeding of Aadhaar with UAN by launching a special drive/holding of camps in clusters having high pendency.

4. Wide publicity may also be ensured and necessary help may also be extended to the establishment for achieving 100% Aadhaar-UAN seeding target by the stipulated date, i.e. 30.06.2024.

5. This must be given utmost priority.

This issues with the approval of Competent Authority.
