- 4. In the absence of any Service personal it shall be the responsibility of the agency to depute another competent and experienced engineer during the period of absence of the designated personnel. For any unauthorised absence of Service personal, the office will fulfil the fault/repairs from third party and the charges of the same will be deducted from the bill / deposits of the contract.
- 5. The CAMC vendor shall provide a stationed Qualified engineer (Service Personal) at EPFO, RO, Vadodara on all working days during office hours throughout the contract period. The agency is required to provide evidence in respect of qualification and experience, which would be checked by EPFO to see the suitability / competency of the service personnel.
- The vendor will have to provide a list of Engineers who will perform the job along with their resume and qualifications who are on their role.
- 7. Any change in the technical service personnel shall be promptly informed to the EPFO, RO, Vadodara. The Service personal provided by the Agency shall not be changed frequently. Only one change will be permitted during the present contract period. For any subsequent changes a penalty of Rs. 5000/- would be payable for each change committed. However, if found incompetent by RPFC, the person has to be changed by the Agency.
- 8. The CAMC vendor will be responsible for repair/maintenance work of hardware including replacement of defective parts (except consumables) at their own cost. The CAMC vendor is also responsible for installation of Operating System, installation and updation of drivers and all softwares provided by EPFO. To the extent possible, all repair and maintenance work would be carried out in EPFO office premises only by the resident engineer within 2 hours of registration of complaint. In case the defect is major and it is not possible to rectify within a day, the problem should be reported to the designated Manager of the EPFO Computer cell and standby equipment should be provided immediately. Minimum 2-3 nos. of each items shall be kept standby at EPFO at their own risk.
- 9. The VENDOR shall rectify any defects, faults and failures in the EQUIPMENT and shall repair and replace worn out of defective parts of the EQUIPMENT during office's normal local working hours i.e from 09:30 am to 06:00 pm on working days or as directed by the office which may require off-office hours.

- 10.The CAMC vendor has no right to refuse to repair any hardware. If repairing is not possible due to non-availability of spares / any other reasons, the hardware with same specification, configuration, cost and in good condition should be provided to EPFO for permanent use by the CAMC vendor at his own cost. In case of addition of peripherals, rates will be fixed as per amount already quoted for similar items reduced proportionately subject to the length of remaining period of contract. In case of deletion of peripherals CAMC charges of the deleted items will not be released for the remaining period of contact.
  - 15.In case the CAMC provider backs out of the contract midstream without explicit consent of the EPFO, the performance guarantee /periodic bills for the period will stand forfeited and amount of CAMC for that guarter will not be released.
  - 16.EPFO shall not be responsible for damages of any kind for any mishap/injury/accident caused to any service engineer of the CAMC Provider while performing duty in EPFO's premises. All liabilities, legal or monetary, shall be borne by the CAMC provider.

- The CAMC vendor will be solely responsible towards all other statutory dues and compliances.
- 18.The contract can be terminated by EPFO at any time without assigning any reason. In this connection the decision of EPFO shall be final and binding on the CAMC vendor.
- 19. The vendor should have at least 5 years' experience of Government of India undertaking, CAMC in PSU Autonomous Organisations/Central Government Organisations etc. Proof of the same need to be produced while applying in Tender.
- 20.The Vendor should not have been blacklisted by any PSU Banks/Private Institutions/Private Companies/Financial Institutions/Autonomous Organisations/Central Government Organisations etc in the past.
- 21.The vendor has to perform PERIODIC MAINTANCE of all the items as per standard process with standard devices. The vendor has to perform PERIODIC MAINTANCE at least quarterly. The office may call the maintenance as per requirement also.
- 22.The CAMC charges will be released on quarterly basis, subject to the vendor submitting to our office, 'Satisfactory Service Reports' from all the user branches/departments and no advance payment shall be made by the EPFO, RO Vadodara.
- 23.The contract will be on comprehensive onsite basis inclusive of repairs and replacement of spare parts including all plastic parts, in case of printer, scanner CPU, peripheral parts without any extra payment.

- 28.THE VENDOR will not subcontract/sublet or permit anyone other than THE VENDOR personnel to perform any of the work, services or other performance required of THE VENDOR under the Contract without the prior written consent of the office.
- 29.THE VENDOR and its personnel shall at all times comply with all security regulations in effect from time to time at office premises and externally for materials belonging to office.
- 30.THE VENDOR shall not copy any software, document or data existing on the hardware or indulge in any other act which may cause malicious damage to the systems. Violation of the same is liable to attract penalty/punishment under IT ACT 2000 as amended from time to time.
