Sir/Madam,

Please refer to the letter dated 24-03-2023 cited above vide which you were request to either furnish a copy of resignation/technical resignation submitted to your current employer or join EPFO by reporting at Zonal Office, Haryana within two weeks of the receipt of the letter failing which your candidature for the post of EO/AO may be cancelled. But you did not report to the concerned Zonal Office.

2. In this regard, vide letter dated 08-05-2023, you were again requested to join on or before 26-05-2023 failing which your candidature shall be cancelled.

3. Subsequently, you had sent a letter from your employer i.e. Social Justice and Empowerment Department dated 26-05-2023 vide which it is informed that state inflation relief camp was going on by the Government and you were requested to reconsider the technical resignation till the camp period. In this regard, a letter was received from you with a request to extend the date of joining till 15-07-2023. Hence, vide letter dated 05-07-2023 it was informed that the Competent Authority had accepted your request to extend the date of joining till 15-07-2023 and you were requested to join on or before the said date failing which your candidature for the post of EO/AO will be cancelled. In this regard, it is noticed that you have not reported to the concerned Zonal Office till date.

4. In view of the above, your appointment has been cancelled by the Competent

Authority. No further communication in this regard will be entertained.
