Madam/Sir,

The Union Public Service Commission (UPSC), through its letter dated 14.08.2024 has recommended 16 candidates for appointment to the post of Enforcement Officer/Accounts Officer (EO/AO) under the 6th Reserve Panel.

2. The pre-appointment formalities, including Document Verification and Medical, have been completed for 9 out of the 16 candidates. These candidates have been allocated to Kerala, Tamil Nadu, and Karnataka Zones. The details of these 9 candidates are listed below:

3. It is informed that the next Tranche of the National Rozgar Mela is scheduled for 23rd December 2024. The Ministry of Home Affairs will organize the events across the country. Details will be forwarded as and when received from MoL&E.
4. The Provisional Appointment Letters issued by Head Office are being forwarded to the concerned Zonal Offices for being distributed through **Rozgar Mela only** to the above mentioned 09 candidates selected for the post EO/AOs. ACC(HQ)/ACC of the concerned Zones are requested to allot these officials to Regional Offices in accordance with the email issued on 19.01.2023 (copy attached).
5. ACC (HQ)/ACC of the Zones are requested to nominate a Nodal Officer not below the rank of RPF-C-II/RPF-C-I for this purpose. If the Zonal Office has already nominated Nodal Officer for JTO, the same Nodal Officer will take care of distribution of Provisional Appointment Letter to these EO/AOs through Rozgar Mela. The Nodal Officers from EPFO will liaison with the Nodal Officers of Ministry of Home Affairs (CRPF/BSF/ITBP) for further details about the Rozgar Mela.
6. The Nodal Officers of allotted offices will have the overall responsibility of ensuring that the above mentioned candidates attend the Rozgar Mela for receipt of Provisional Appointment Letters.
6. The EO/AOs may join at their place of posting immediately on receipt of Provisional Appointment letter. The concerned Regional Office where the candidate joins, is requested to send a copy of the Joining Order of the EO/AOs to Recruitment Division immediately on their joining at email id- dreoao.2022@epfindia.gov.in
7. Those candidates who are already in Govt./ Semi-Govt./ PSU/ Undertaking of Govt. of India/State etc. are requested to submit their proper discharge certificate from their previous employer at the time of joining in EPFO.
8. The concerned Regional Office where the candidate joins, is requested to get the Character and Antecedent Verification done from the concerned District/ Police Authorities in accordance with Head Office Order No. A-12011/12/2024-EPFO-HQ/RC/328 dated 07.11.2024 within 6 months of joining of the candidate. The Caste/PwBD/EWS certificates submitted by the candidate may also be verified from the issuing authority. On receipt of Character and Antecedent Verification report and confirmation of Caste/PwBD/EWS certificates of the candidates, the Head Office will issue the Final Appointment Letter to the candidates.
