OFFER OF APPOINTMENT

Sub: Appointment of Shri Dharam Raj Maurya, Assistant Audit Officer, O/o The Principal Director of Audit, Finance & Communication, Shamnath Marg (Near Old Secretariat), Delhi – 110 054 as Assistant Director (Audit) in Employees' Provident Fund Organisation on deputation basis.

On the basis of the recommendation of the Selection Committee constituted for selection to the post of Assistant Director (Audit) on deputation basis in EPFO, **Shri Dharam Raj Maurya, Assistant Audit Officer, O/o The Principal Director of Audit, Finance & Communication, Shamnath Marg (Near Old Secretariat), Delhi – 110 054** is hereby issued an offer of appointment for the post of Assistant Director (Audit) in Employees' Provident Fund Organisation in Level-10 of the Pay Matrix [Pay Band-3 Rs. 15600-39100 with Grade Pay Rs. 5400/-(pre-revised)] on deputation basis initially for a period for three years from the date of joining the post of Assistant Director (Audit).

2. The terms and conditions of appointment on deputation are as follows:-

- i) The terms and conditions of deputation will be governed by O.M. No. 2/229/91-Estt./(Pay II) dated 05.01.1994, O.M. No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 and other instructions / Memorandum issued by Ministry of Personnel, Public Grievances and Pension, Department of Personnel & Training, Government of India from time to time.
- ii) The posting of the official as Assistant Director (Audit) shall be at **IAP, Kanpur**. However, the official may be transferred to any other EPFO office location on administrative grounds.
- iii) The order of appointment will be issued once the written consent of the concerned officer is received accepting the offer of appointment subject to the above terms and conditions.
- iv) S/he will be entitled to TA/DA and joining time as per rules.
- v) On expiry of three years from the date of joining the post, the deputationist officer will be deemed to have been relieved on the date of expiry of the deputation period unless the Competent Authority has with requisite approvals, extend the period of deputation in writing, prior to the date of its expiry.
- vi) In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse consequences which would include that the period of unauthorized overstay shall not count against service for the purpose of

pension and that any increment due during the period of unauthorized overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre.

3. If the above terms and conditions are acceptable, **Shri Dharam Raj Maurya, Assistant Audit Officer** may send written consent through proper channel alongwith latest Vigilance Clearance Certificate to this office within **15 days** of receipt of this offer of appointment.
