OFFER OF APPOINTMENT

Subject: Appointment of Shri Jitender Singh Meena, Section Supervisor, Regional Office, Delhi (Central) as Assistant Audit Officer on deputation basis in Employees' Provident Fund Organisation.

On the basis of the recommendation of the Selection Committee constituted for selection to the post of Assistant Audit Officer, **Shri Jitender Singh Meena, Section Supervisor** is hereby issued an offer of appointment for the post of Assistant Audit Officer in Employees' Provident Fund Organisation in Level-7 of the Pay Matrix [Pay Band-2 Rs.9300-34800 with Grade Pay Rs. 4600/-(pre-revised)] on deputation basis initially for a period of three years from the date of joining the post of Assistant Audit Officer.

2. The terms and conditions of appointment on deputation are as follows:-
- The terms and conditions of deputation will be governed by O.M. No. 2/229/91-Estt./(Pay II) dated 05.01.1994, O.M. No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 and other instructions / Memorandum issued by Ministry of Personnel, Public Grievances and Pension, Department of Personnel & Training, Government of India from time to time.
 - The posting of the official as Assistant Audit Officer shall be at **IAP, Head Office, New Delhi**. However, the official may be transferred to any other EPFO office location on administrative grounds.
 - The order of appointment will be issued once the written consent of the concerned officer is received accepting the offer of appointment subject to the above terms and conditions.
 - S/he will be entitled to TA/DA and joining time as per rules.
 - In case the selected official seeks repatriation before completion of two years on deputation, no Transfer TA/DA will be paid on repatriation. Further, if any official seeks repatriation within one year or less, Transfer TA/DA already paid, if any is also liable to be recovered.
 - On expiry of three years from the date of joining the post, the deputationist officer will be deemed to have been relieved on the date of expiry of the deputation period unless the Competent Authority has with requisite approvals, extend the period of deputation in writing, prior to the date of its expiry.
 - In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse consequences which would include that the period of unauthorized overstay shall not count against service for the purpose of pension and that any increment due during the period of unauthorized overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre.

3. If the above terms and conditions are acceptable, **Shri Jitender Singh Meena, Section Supervisor** may send written consent through proper channel alongwith latest Vigilance Clearance Certificate to this office within **10 days** of receipt of this offer of appointment.
