4. Those candidates who are already in Govt./ Semi-Govt./ PSU/ Undertaking of Govt. of India/State etc. are requested to submit their proper discharge certificate from their previous employer at the time of joining in EPFO.

5. The concerned ZO/PDNASS/ASD/RO/ZTI where the candidate joins, are requested to get the Character and Antecedent Verification done from the concerned District/ Police Authorities in accordance with Head Office Order No. A-12011/12/2024-EPFO-HQ/RC/328 dated 07.11.2024 within 6 months of joining of the candidate. The Caste/PwBD/EWS certificates submitted by the candidate may also be got confirmed from the issuing authority. On receipt of Character and Antecedent Verification report and confirmation of Caste/PwBD/EWS certificates of the candidates, the ROs/ASD mentioned at 6th Column above will issue the Final Appointment Letter to the candidate.
