
### OFFICE ORDER

The seniority of the officer will be regulated in the cadre of Assistant P.F. Commissioner as per the provisions of EPF Staff (Fixation of Seniority) Regulations, 1989.

- In accordance with DoP&T No. OM No. 36012/16/2019- Estt.(Res) dated 12.04.2022, reservation in promotion has been applied but the instant promotion order is subject to the outcome of Jarnail Singh batch of cases which are pending before Hon'ble Supreme Court of India and any promotion order issued shall be subject to further orders that may be passed by the Supreme Court in the said batch of cases.


