**PROVISIONAL LETTER OF APPOINTMENT**

**Subject: Provisional appointment of DEVENDRA PRATAP KUSHWAHA to the post of Assistant Provident Fund Commissioner in the Pay Matrix Level 10 (pre-revised PB-3 Rs. 15600- 39100 with grade pay of Rs.5400/-) in Employees' Provident Fund Organisation-Regarding.**

The Central Provident Fund Commissioner, on the recommendation of the Union Public Service Commission vide its Letter No.F.1/165(33)2022-R.IV/SPC-I dated 19.07.2024 is pleased to provisionally appoint **DEVENDRA PRATAP KUSHWAHA** as Assistant Provident Fund Commissioner in the Pay Matrix Level 10 (pre-revised PB-3 Rs. 15600- 39100 with grade pay of Rs.5400/-) in Employees' Provident Fund Organisation on acceptance of the terms and conditions issued vide Zonal Office vide Offer of Appointment vide Letter No. Letter No. 1031/ACC(UP)/Adm/APFC/DR-2024/F-924(48) dated 21.08.2024.

2. DEVENDRA PRATAP KUSHWAHA shall be on probation for one (01) year from the date of his joining the post. The successful completion of the period of probation not only requires passing the requisite departmental probationary examination for Assistant Provident Fund Commissioner but also completion of prescribed training programmes. His services are liable to be terminated in case he fails to qualify for the probationary examination within the period of probation or extended period of probation. On successful completion of probation, he would be considered for appointment on a substantive basis to the post of Assistant Provident Fund Commissioner in the Employees' Provident Fund Organisation.

3. His seniority among other candidates selected by the Union Public Service Commission will be determined in accordance with the rank assigned by the Union Public Service Commission in the select list and is further subject to the provisions contained in the Employees' Provident Fund (Officers and Employees' Conditions of Service) Regulations, 2008 and Employees' Provident Fund Staff (Fixation of Seniority) Regulations, 1989.

4. It may be noted that the appointment is provisional and is subject to the caste/tribe certificate being verified through the proper channel and if the verification reveals that the claim of Scheduled Castes/Scheduled Tribe/Other Backward Class/EWS/PwBDs, as the case may be, is false, the services of the officer will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under provisions of the Bharatiya Nyaya Sanhita, 2023 for production of false certificates. On his appointment to the post of Assistant Provident Fund Commissioner, his pay will be fixed as per rules.

5. The appointment is further provisional subject to the satisfactory receipt of the Police Verification Report from concerned District Authorities as per the details indicated by the candidate in the Attestation Form received from the UPSC. In case the character and antecedents of the candidate are found not verified or any false information is given by the candidate in his self-declaration or any unfair means were used by the candidate in the whole selection process, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken, as a consequence. Further, in case any of the information is found incorrect, or in case, the verification confirms that facts given by the candidate were not correct, then the Appointing Authority shall cancel the appointment letter forthwith. The candidate shall be rendered unfit for any Government employment and Appointing Authority shall undertake other criminal/civil/legal action, as per provisions of Bharatiya Nyaya Sanhita, 2023 etc. as deemed fit.

6. He is directed to report at **Regional Office, Vashi, Tower No.6, 5th Floor, Vashi Railway Station Complex, (Maharashtra). Vashi - 400 703** positively by **15.10.2024**. In case he fails to join without any sufficient cause, his candidature may be cancelled without any further notice. Further instructions regarding the Induction Training Programme for APFCs will be communicated to the candidate separately by Director, PDNASS.

7. At the time of reporting/joining at the above office, the candidate shall produce a copy of this provisional letter of appointment along with copy of his Aadhaar and PAN Card. A candidate who is already in service shall produce the original relieving order/documents of valid discharge from his respective authorities in the previous Department/Organization.

8. Further, it is informed that Court case W.P.C. No. 4200/2024 is pending in the Hon'ble High Court of Delhi. While considering and disposing off the CM APPL. 17158/2024 - Stay, the Hon'ble High Court of Delhi vide its order dated 20.03.2024 has directed that the appointments of Assistant Provident Fund Commissioners pursuant to the special advertisement no 51/2023 would remain subject to outcome of the W.P (C) No. 4200/2024. Hence this Provisional Appointment Letter is issued subject to final outcome of the above stated WP(C) and any other pending court case in this matter.

9. The provisional appointment order of DEVENDRA PRATAP KUSHWAHA is issued with the approval of the Central Provident Fund Commissioner.
