**NOTIFICATION**

M/s Dempo Dairy Industries Ltd., Asangi – KN/9300 is an establishment covered under Employees' Provident Funds & Miscellaneous Provisions Act, 1952. The establishment was granted exemption under Section 17 (1) (a) of the Act by the Government of Karnataka vide Notification No. SWL 4 LPF 06 dated: 31.07.1986/01.08.1986. The establishment is complying with the provisions of the EPF & MP Act 1952 and remittances have been received upto August 2024.

The establishment had submitted a request for surrender of the PF Trust and cancellation of Exemption vide their application dated: 25.06.2011 due to Administrative inconveniences and non viability of running the P.F. Trust and also extreme difficulty in meeting recent interest burden of 9.5% per annum.

The Board of Trustees have resolved to surrender the application of M/s Dempo Dairy Industries Ltd., Asangi – KN/9300 for a formal Surrender of exemption granted under section 17 (1) (a) of EPF & MP Act, 1952. Trust Exemption w.e.f. 1<sup>st</sup> July 2011.

Now, therefore, in exercise of powers conferred under section 17 (4) of EPF & MP Act, 1952 the Govt. of Karnataka hereby cancel the exemption granted under clause (a) of sub section (1) of Section 17 of the said act to M/s Dempo Dairy Industries Ltd., Asangi – KN/9300 issued vide Notification No. SWL 4 LPF 06 dated: 31.07.1986/01.08.1986 w.e.f. 01.07.2011.
