NOTIFICATION

**Whereas**, the Governor was pleased to exempt the establishment namely M/s Premier Suppliers Pvt. Ltd. C-1, Gillander House, 8, Netaji Subhas Road, Kolkata-700001 against P.F. Code No. WB/8323 vide Notification No. 365-P.F. dated 26/03/1964 under section 17(1) (a) of the Employees Provident Fund & Miscellaneous Provisions Act, 1952 from the operation of all provisions of the said act of Employees Provident Fund Scheme, 1952 subject to the conditions specified therein

**Whereas**, the establishment had expressed their willingness to surrender the exemption to the appropriate Government, Vide No. PSP 116 dated 30/11/2010 and PSP/2020-21/22 dated 08/09/2020.

**Whereas**, Regional P.F. Commissioner-I, Kolkata has recommended the cancellation of the establishment vide No R-Ex/8323/WB/CA CC-VI/9048 dated 10/09/2011.

**Whereas**, the trust has passed the resolution to surrender the exemption w.e.f. 01/01/2020.

**Whereas**, an order dated 10/09/2020 was issued to the establishment for transfer of PA accumulation and to comply as unexempted establishment w.e.f. 01/10/2020.

**Whereas**, the establishment has transferred the fund of Rs. 4385675.91/- against the due of Rs. 4239714/-.

**Whereas**, the Regional P.F. Commissioner, Kolkata, has reported that the establishment has transferred the past accumulations and started complying as unexempted establishment w.e.f. 01/01/2020.

Whereas, the Central Board of Trustees has considered the prayer of the establishment for surrendering the exemption in its 233<sup>rd</sup> meeting held on 27/03/2023 and recommended the cancellation of exemption under section 17(4) of EPF & MP Act, 1952.

Therefore, after considering the proposal of EPFO authority and the correspondence and available documents, it may be declared that M/s Premier Suppliers Private Limited, P.F. Code No. WB/8323 has surrendered their exemption granted and converted into an exempted establishment and deposited dues up to the wage month 03/2022. A formal cancellation of the exemption granted to the establishment, may be required to overcome the legal ambiguity.

Now, the Governor is here by pleased to cancel the granted exemption in favour of M/s Premier Suppliers Pvt. Ltd. C-4, Gillander House, 8, Netaji Subhas Road, Kolkata-700001, against the EPF Code No. WB/8323 Vide Notification No. 365-P.F. dated 26/03/1664 under section 17(4) of the Employees Provident Fund and Miscellaneous Provisions Act, 1952 and as per section 27A of the Employees Provident Fund Scheme-1952, from the date of issuance of the Notification.
