## NOTIFICATION

M/s. NITK Surathkal Hostels, Mangalore, KN/5036 is an establishment covered under Employees' Provident Funds & Miscellaneous Provisions Act, 1952. The establishment was granted exemption under Section 17 (1) (a) of the Act by the Government of Karnataka vide Notification No. SWL 28 LPF 79 dated: 02.01.1980. Accordingly, it was maintaining a Provident Fund Trust in the name of "National Institute of Technology Karnataka Surathkal Hostels Trust".

Due to difficulty in maintaining the Trust, their Board of Trustees on 26.02.2018 unanimously passed a resolution to surrender exemption w.e.f. 01.04.2018.

The Central Board of Trustees, EPF has recommended the acceptance of Surrender application of M/S. NITK Surathkal Hostels, Mangalore, KN/5036 for a formal Surrender of exemption granted under section 17 (1) (a) of EPF & MP Act, 1952. The establishment has started reporting compliance to EPFO with effect from 01.03.2018 and all the securities along with past accumulation of the members lying in the PF Trust has also been transferred in the name of Central Board of Trustees, EPF.

Now, therefore, in exercise of powers conferred under section 17 (4) of EPF & MP Act, 1952 the Govt. of Karnataka hereby cancel the exemption granted under clause (a) of sub section (1) of Section 17 of the said act to M/s. NITK Surathkal Hostels, Mangalore, KN/5036 issued vide Notification No. SWL 28 LPF 79 dated: 02.01.1980 w.e.f. 01.04.2018.
