## ORDER

Whereas M/s Ramdas Motor Transport Ltd. (AP/RJY/7) (hereinafter referred to as the Establishment) was granted exemption under clause (a) of sub-section (1) of Section 17 of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 (19 of 1952) (hereinafter referred to as the said Act) by the Central Government vide notification no. S-35015/3/92-SS-II dated 22/07/92, subject to the conditions specified in this regard from time to time;

- And whereas the Employees' Provident Fund Organisation has submitted a proposal for surrender of exemption granted to the establishment stating that the establishment is facing difficulties for earning interest on Investments money and meeting the interest rate declaring by Central Government and Employees Provident Fund Organisation.
- And whereas now it has come to the notice that the establishment has surrendered its exemption with effect from 01.10.2016 and started complying as un-exempted establishment w.e.f. 01.10.2016.
- Now, therefore, in exercise of the powers conferred by sub-section (4) of section 17 of the said Act, the Central Government, being the authority that granted the said exemption to the Establishment, hereby cancel the exemption so granted to the Establishment w.e.f. 01.10.2016.
