NOTIFICATION

(PROVIDENT FUND)

Whereas, the Governor was pleased to exempt the establishment namely, M/S Xavier Labour Relations Institute, Jamshedpur (XLRI) against the EPF code No. JH/JAM/4116 vide notification No. 1610, dated 03.11.2009 under section 17(1)(a) of the Employees' Provident Fund & Miscellaneous Provisions Act, 1952 from the operation of provisions of the said Act of Employees' Provident Fund Scheme, 1952, subject to the conditions specified therein.

Whereas, it has been reported by the Addl. Central P.F. Commissioner (Exemption) vide letter No. E-III/10(77)2023/Misc/5352, Dated 20.03.2024 that

- i. The board of Trustees on 29.11.2017 unanimously passed a resolution to surrender exemption w.e.f 01.04.2020.
- ii. The application of the establishment for surrender of Exemption was placed before the Exempted Establishments' Committee of the Central Board, in their 54th EEC meeting held on 31.05.2023 and subsequently to the 234th meeting of the Central Board of Trustees, held on 31.10.2023.
- iii. The establishment has furnished the third party Audit Report from 01.04.2020 to 17.02.2022.
- iv. The Central Board of Trustees has recommended the acceptance of Surrender Application of M/S Xavier Labour Relations Institute, Jamshedpur (XLRI), EPF code No. JH/JAM/4116 for a formal surrender of exemption granted under section 17 (1) (a) of EPF & MP Act, 1952.

And whereas the Jurisdictional Regional Provident Fund Commissioner/OIC, Jamshedpur has also reported that the establishment has started reporting compliance to EPFO with effect from 01.04.2020 and all the securities along with past accumulation of the members lying in the PF Trust has also been transferred in the name of Central Board of Trustees, EPF.

And whereas Central EPFO has requested to consider for issuance of necessary formal order regarding cancellation of exemption in respect of the said establishment.

After considering the proposal of EPFO authority and the correspondences, documents, it may be deduced that M/S Xavier Labour Relations Institute, Jamshedpur (XLRI) has surrendered it's exemption and act as unexempted establishment, the recommendation of cancellation from the EPFO authority seems to be appropriate and valid.

Now, the Governor is hereby pleased to cancel the exemption of the M/S Xavier Labour Relations Institute, Jamshedpur (XLRI) against the EPF code No. JH/JAM/4116 vide Notification No 1610 Dt. 03.11.2009 as per section 17(4) of the Employees Provident Fund Miscellaneous Provisions Act, 1952 w.e.f. 01.04.2020.
