NOTIFICATION

Whereas, vide Government of Karnataka Notification No. ML/LPF/75 dated: 19.02.1975 exemption was granted under Section 17 (1) of the Employees Provident Fund & Miscellaneous Provisions Act, 1952 to M/s South Canara District Central Coop Bank Ltd (KN/2814) subject to certain conditions.

The Employees Provident Fund Organization HQ vide its letter No. E-III/ 7(6) 2010/KN/Cancellation/ Exemption 14290 dated: 23.11.2016, has conveyed that, the establishment has requested vide application dated: 16.09.2010 for surrender of exemption because of difficulty in maintaining Provident Fund Trust. The establishment's application received through Regional Provident Fund Commissioner, Regional Office, Mangalore. In view of the request of the establishment, the Regional Provident Fund Commissioner concerned has directed the employer to transfer past accumulations and comply as un-exempted establishment w.e.f. 01.09.2016 and also stated that the State Govt of Karnataka is the appropriate Authority as per Section 17 (4) of the EPF & MP Act, 1952 to consider the request of the establishment for cancellation of exemption and issue notification.

Now, therefore in exercise of the powers conferred by sub section (4) of Section 17 of the Employees Provident Fund & Miscellaneous Provisions Act 1952 (Central Act XIX of 1952) the Government of Karnataka hereby cancels the Exemption granted under clause (a) of sub Section (1) of Section 17 of the Employees Provident Fund & Miscellaneous Provisions Act 1952 to M/S South Canara District Central Coop Bank Ltd (KN/2814) with effect from 01.09.2016.
